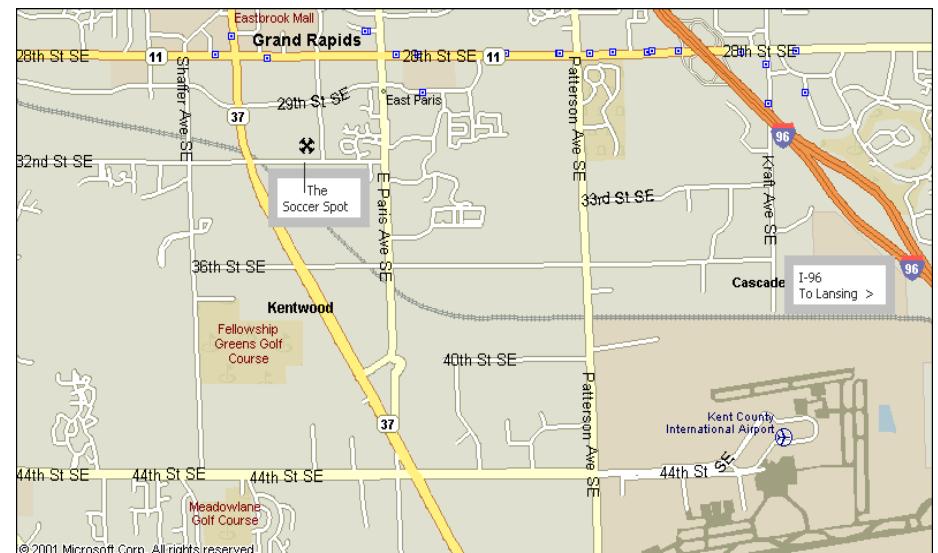

## NOTICE TO EXHIBITORS

- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all exercises safely.
- **Dogs under the age of 6 months are not permitted on the show grounds**
- Entry fees will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by the action of the show committee. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- The club may cancel this event due to extreme weather conditions.
- Refunds minus \$10/day administrative fees will be given to bitches in season and all dogs that can't compete due to injury upon receipt of an excuse from a licensed veterinarian written on his/her letterhead. All refund requests must be received within 2 weeks of end of trial.
- .Returned checks do not constitute a valid entry fee. There will be a \$25.00 service charge for returned checks.
- Overpayments of less than \$10 will be considered a donation to the club and will not be returned.
- It is expressly understood that the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site.
